As a member of PaLM, the Medical Laboratory Technologist (MLT) works under the supervision of the Manager for the Molecular Diagnostics Program in coordination with the Senior Medical Laboratory Technologists. MLTs in the Cytogenetics Laboratory are responsible for testing for chromosomal aberrations and gene rearrangements causing developmental disorders and malignant diseases. The Medical Laboratory Technologist will perform Classic and Molecular Cytogenetic procedures in accordance with written Laboratory protocols and Provincial Licensing Regulations under the general supervision of the Section Head.

Staff in PaLM may be assigned to London Health Sciences Centre (University Hospital, Victoria Hospital), St. Joseph's Health Care, or other sites as required
