

## **REGISTRATION ELIGIBILITY AND INFORMATION FOR STUDENTS**

Online registration for the **September 12, 2024, MLPAO MLA/T Certification Online Exam** will be open from May 27, 2024, until July 25, 2024.

Successful completion of an MLA/T course from an approved MLPAO school is required, for candidates to be eligible to write the MLPAO MLA/T online exam.

MLA/T students are not eligible to register for the MLPAO Certification Exam if they have not completed all MLA/T program course requirements <u>including</u> clinical placement. Any students registering to write the online exam must have completed <u>all</u> course requirements <u>including</u> clinical placement and provide a copy of their diploma or graduation confirmation letter from their school <u>by the registration deadline</u>.

We recognize that some students may complete the program prior to the exam but not have their diploma by the registration deadline, in this case:

- 1. A student who has not completed the MLA/T program before the registration date but will complete BEFORE the exam date (including clinical placement), can register for the exam IF the school provides a letter of confirmation that the student will have completed the entire program prior to the exam date. The letter must be dated during the exam registration period and MUST BE RECEIVED BEFORE THE REGISTRATION DEADLINE. It is the student's responsibility to obtain the letter from their school and forward to MLPAO. If the student passes the exam, the student's certificate will be on hold until course diploma is received.
- 2. If a student has completed course work and is currently in placement, but will NOT complete placement <u>before</u> exam date, the student is **NOT** eligible to register for that exam.

Proof of completion document must be emailed to <a href="maileo!exam@MLPAO.org"><u>Exam@MLPAO.org</u></a> no later than the registration deadline of <a href="maileo!exam">July 25, 2024</a>. Subject line should read "September 2024 exam – completion doc".

If students would like the discounted student MLPAO member exam rate, they need to register for an MLPAO Student Membership before registering for the exam.

To do this they will need to upload a Word or PDF document with their proof of school enrollment. We accept a picture of their student card or a copy of their enrollment letter/agreement.

They will select Student Medical Laboratory Assistant/Technician.

The MLPAO MLA/T exam is an online exam with live online proctoring. A working computer/laptop with a microphone, webcam, speakers, and a strong internet connection are required if selecting the online at home option.
